A BYLAW TO AMEND "VILLAGE OF CLINTON ZONING BYLAW NO. 439, 2007"

WHEREAS

an application (No. 2010-ZAM-001) for amendment to Zoning

Bylaw No. 439, 2007 has been made;

the desirable changes in uses of land have been considered;

1. **CITATION**

This Bylaw may be cited as "Village of Clinton Zoning Bylaw No. 439, 2007 Amendment Bylaw No. 476, 2010".

2. PURPOSE

- a) The zoning classification on Lots 5 and 6, Plan KAP68363, District Lot 1060, Lillooet Land District, Clinton Townsite, as outlined in red on the map attached hereto as Schedule "A" is changed from the I-1 (Light Industrial) Zone to the I-2 (Heavy Industrial) Zone.
- b) The map attached hereto as Schedule "A" is incorporated in and forms part of this bylaw.



<u>Summary</u>

Alan Weller has applied for rezoning from Light Industrial to Heavy Industrial to allow for a scrap metal

The Bylaw was taken to 1st and 2nd reading at the regular meeting of Council and proceeded to a Public Hearing at the Committee of the Whole meeting preceding the regular meeting of Council on June 9th. If no changes have resulted from the Public Hearing, then the bylaw can be read for the third time and adopted at this time if Council so chooses. Mr. Weller will still need to apply for a development permit as stated in the Village of Clinton Official Community Plan. At that time the following restrictions can be implemented:

- a. The fence be built structurally sound enough to withstand strong winds;
- b. The fence design be approved by Village Staff;
- c. The fence be maintained in accordance with Village of Clinton Unsightly Premises Bylaw 434, 2006:
- d. That at no time is the scrap to exceed the height of the fence;
- e. That the berm be landscaped and maintained to suit the natural surroundings in accordance to Staff specifications;
- That noxious weeds on the berm be controlled; f.
- That the fence meets all applicable regulatory requirements.

Recommendation

That a bylaw to amend "Village of Clinton Zoning Bylaw No. 439, 2010" Bylaw No. 476, 2010 be read for the third time and adopted; further that Mr. Weller be required to apply for a Development Variance Permit"
