- Spread: It spreads slowly by rhizomes and seeds.

THAT Council of the Village of Clinton authorize staff to proceed with the notification process, including notification of adjoining property owners, of Council's intent to consider issuance of a Development Variance Permit to James Woods and Sarah Munroe for the property located at 1504 Cariboo Hwy, and legally described as Lot A, Plan KAP8160, District Lot 1, Group 5, Lillooet land district and the property located at 1506 Cariboo Hwy, and legally described as Lot B, Plan KAP8160, District Lot 1, Group 5, Lillooet land district, Except Plan 35605 to vary Zoning Bylaw No. 439, 2007, s. 17.3 a) from the requirement for 13 parking spaces to only 5 parking spaces, in substantial accordance with the application as submitted on May 16, 2025.

Background:

The owner of 1521 Cariboo Hwy has applied for a development Variance Permit to vary the parking requirements of the Zoning Bylaw in the following ways:

Reduce number of required off-street parking spaces from 13 to 5.

The application has been referred to the following agencies. Their comments are indicated below:

Fortis BC: No response

Ministry of Transportation and Transit: No concerns Clinton Volunteer Fire Department: No concerns

Village of Clinton Public Works Department: No concerns

Staff confirmed with the applicant that the parking spaces which have been proposed are standard size (7.5m x 3m) and that there is enough space on the site as indicated by the applicant. The easement on the property, indicated on the map by a thick black border, is to maintain access to a Village water main and will not be affected by the parking areas indicated in the application. However, the area may become congested, and issues arise if patrons park on both sides of the alley. Once comments from adjacent property owners are received, Staff may recommend the installation of No Parking Signs and or barriers to be installed as a condition of the permit.

As there are only one or two staff members, and the building is not being used as a dwelling, more spots will remain available for customers. There are many on-street parking spaces within a reasonable walking distance of the property and parking is rarely at capacity. Other than during peak tourism season and the possible congestion mentioned above, Administration does not anticipate any significant concerns about parking in the general vicinity.

Administration has reviewed the application and referral responses, and recommends moving forward with the DVP. The next step in the process is to pass a resolution to proceed with notifying adjacent property owners of Council's intent to offer the DVP to the applicant. The responses will be compiled and presented to Council at the next meeting, at which point Council can issue the permit.

This report presents Council with the responses from the public engagement program carried out for the Multi-use Court Project.

Background:

During the week of May 12th, the Village hand-delivered letters to residences adjacent to or having significant sight lines to the site of the proposed multi-use court location. A notice was also posted on the Village's website and Facebook page. Those interested in commenting were asked to submit written comments to the Village office in person or by email.

In total, five responses were received by the May 22nd deadline. Four of the responses are attached to this report. One additional response contained private information that cannot be presented on a public agenda according to the Freedom of Information and Protection of Privacy Act. The report can be summarized as follows:

An individual expressed that poor mental health conditions will be made worse by the constant sound of the basketball.

Unless Council wishes to consider changes to the project based on the comments received, Administration will continue to work on the RFP to obtain detailed proposals for the development of the court.

OTHER Activities: Silga convention April 29th to May 02

Tuesday — first seminar attended was about tourism transformed and visitor centre strategies: covered off areas of concern such as developing a visitors strategy, focus on off season and shoulder season, need a diverse groups to support community events, developing a destination tourism plan. Ideas that were discussed included a picture tour in the community, create a tourism photo contest to build a photo bank, tear sheet maps in local restaurants as well as information pamphlets in hotel rooms. Some communities adopted a 2% hotel tax to support tourism initiatives.

The second discussion was health human resource strategy: this subject has been discussed for well over 20 years with recruitment still the main factor. There was some number crunching as to possible recruitment opportunities but the main hindering factor is the college of physicians with their policies, red tape and high examination fees. The work is starting; to eliminate interprovincial red tape as a physician or nurse should be able to work anywhere in Canada.

Wednesday April 30th: economic development in the southern interior. Presentation was done by ETSI-BC being one of the 3 regionals that provide grant funding. Discussed rural business community recovery as well as comprehensive revitalization plans. Projects are 100% funded for communities under 750 in population.

Attended the opening ceremonies and walked through the trade show.



Thursday May 01: culture and arts. Discussed various forms of music culture and festival culture. Looked at the Various outcomes of the merit mountain music festival as well as the Hedley music festivals. Discussed street markets, local entrepreneurship, buskers of various food vendors as well as downtown revitalization. Looked at economic transition as more young people are looking at rural BC, focusing on quality of life over quantity and looking at opportunities to make climate change opportunities.

Culture isn't fluff as it creates infrastructure for belonging, innovation and economic growth. It builds community pride and cohesion. People don't just travel to places; they travel for experiences such as heritage festivals, mural tours as well as artisan markets. Develop clear goals and cultural strategies through developing partnerships with artist led initiative.

Friday May 02: attended a presentation on what is a business improvement area. Focus was on marketing, community charm, vibrancy and being an advocate for actions. Focus was also on reducing the cost of doing business by developing a solution based mindset.

May 15th TNRD meeting. Presentation by Valley Rail feasibility research who is looking at implementing an electric passenger rail train from Osoyoos to Kamloops. Received the 2024 TNRD annual report.

Tuesday 29th ... Bees, Bison, and Beer tour.

30 Min bus ride west on hyw 8 and up the mountain to a small bee farm/ranch. The hilite I got from this was I now have a total real respect for that little jar of honey. The total amount of work year round that goes into that little jar is crazy. Never mind the time/energy for marketing etc.

The whole process at this place was old school, nothing hi-tech but very sufficient and productive.

On the bus again for about 45min ride towards Kamloops on the old hyw 5 and up the mountain again [different one] to a small Bison ranch probably 15 head /1 bull. Wow what a view from the top . Anyways this ranch is small and one of the first and here again old school.

The Bison [Buffalo] were roaming freely with only perimeter fencing only. No fencing between the house deck that we were on and Bison. They were very calm and that bull was big at approx. 2700 yet still trying to get him to 3200.
