Background:

The Village conducted a tax sale on September 29th and October 1st in accordance with the Local Government Act. The successful bidder was Mr. David Park who currently serves as a councillor for the Village but who bid on his own behalf during the auction. Following the sale, the Village received a complaint from a bidder (letter attached) that the tax sale was conducted in an unfair manner. The complainant is requesting that the tax sale be set aside. Council may have the Tax Sale declared invalid under section 668 of the Local Government Act if it deems that a "manifest error" in the tax sale has occurred:

Council authority to cancel sale in case of error

- 668. (1) During the period allowed for redemption, if the council finds a manifest error in the tax sale or in the proceedings before the sale, it may order that
 - the purchase price be returned to the purchaser together with interest at the rate prescribed under subsection (2), and
 - (b) the taxes be dealt with as the circumstances require, either
 - (i) by restoring the taxes as they were before the sale, or
 - (ii) otherwise as directed by the council.
 - (2) The Lieutenant Governor in Council may prescribe a rate of interest for the purposes of subsection (1) (a).

RS2015-1-668 (B.C. Reg. 257/2015).

While "Manifest Error" is not defined in the legislation, the word "manifest" indicates it must be an "obvious" error. Administration does not believe that there was a "manifest" (or "obvious") error in the tax sale.

In response to Mr. Kuester's concerns:

Response to paragraphs 1 and 2: The Local Government Act and Community Charter grant broad authority for the auctioneer to set the terms of the auction. There are no legislated requirements to display the terms in writing, and there is no requirement to ensure the terms do not change when the need arises. The terms of the auction were verbally conveyed to the bidders in advance of each auction.

Response to paragraph 3: When sending the notice of Tax Sale via the VoyentAlert! App, Staff discovered that for text recipients, the address of the recipient is listed after the alert title [ex, 2025 tax sale (1423 Cariboo Hwy)]. To avoid confusion, the Village issued an additional alert indicating that the address of the property was not the same as the address listed in the alert title, and that recipients simply had to scroll down to see the tax sale property listing in the body of the alert. In both notices the correct property address was used. At the first auction, the auctioneer misspoke and said the wrong address but corrected himself immediately, before the bidding commenced. The address was announced correctly when the auction was subsequently reconvened.

Response to paragraph 4: The decision to change the minimum bid increment was applied to all bidders equally and served to speed up the auction as it had not been proceeding in a timely manner due to the initial small bid increments. With the increased bid increments, the complainant was the highest bidder in the first auction.

Response to paragraph 5: Only the first day of the auction is required to be announced on the Village's official public notice posting place. The Village adjourned the auction to a set time after each time it was reconvened which was known to all attendees. When the auction was reconvened on October 1st, it began at 9:58 AM rather than at 10:00 AM as previously scheduled because all registered bidders were in attendance. There was no one who arrived at 10:00 am would wanted to bid but could not due to the timing of when it had started.

Response to paragraph 6: As two bidders had contravened the terms of the auction by bidding money that was unavailable to them, those individuals were subsequently disqualified from bidding. By making a bid, and then not being able to pay, the disqualified bidders caused the auction to be redone twice. Section 650(4) of the LGA states: "If a purchaser fails to immediately pay the collector the amount of the purchase price, the collector must promptly again offer the parcel for sale." In the third auction, the auctioneer wished to clarify that the disqualification extended to others bidding on their behalf, in case a bidder tried to circumvent the disqualification by means of a proxy which would be against the intent of the prohibition. As such, the auctioneer asked bidders to declare if they intended to bid on behalf of another individual.

Response to paragraph 7: Regarding accusations of conflict of interest, the legislation does not disqualify a sitting councillor from bidding on their own behalf, nor does it specify that a bidder cannot have special interest in or access to the property. Also, it was not as a result of Mr. Park's role as a councillor that he has access to the property. Administration can identify no legitimate grounds for a conflict of interest in the complainant's allegations.

Response to paragraph 8: The letter provided to the complainant is attached to this report. Administration is of the view that the letter was appropriate as it informed the complainant of his options and suggested he may want to seek legal advice.

Financial Impacts:

If the tax sale is set aside, the Village will need to repay the purchase price plus interest. The unpaid taxes can be restored and, if unpaid, the property will proceed to tax sale again in 2026.

Hi Roy,

I have reviewed the situation regarding the tax sale, and I am satisfied that it was run fairly and according to the relevant legislation. If you disagree with me, you could ask council to set aside the tax sale on the basis of council determining that there was a "manifest error" in the sale (see s. 668 of the Local Government Act). If you wish to contact members of Council, their emails are available on the Village Website, and it will be up to them to decide to bring the topic forward for discussion. I am unable to advise you on how you might pursue other options, and I recommend you seek independent legal advice. Regarding your claims of "conflict of interest", the legislation does not preclude a CAO from running a tax sale, nor a sitting member of Council from bidding.

Dear Ombudsperson,

I am writing to file a formal complaint regarding the conduct and administration of a recent **property tax sale held by the Village of Clinton from September 29 to October 1, 2025.** I believe that the sale was handled in a manner that lacked transparency, consistency, and fairness, and may have involved a conflict of interest.

Below is a summary of my concerns:

1. Lack of Written Rules:

The Chief Administrative Officer (CAO) refused to provide written rules or procedures governing the auction process despite multiple requests.

2. Changing Rules During the Auctions:

The CAO verbally announced the rules at the beginning but then changed them multiple times over the course of the three auctions that were held.

3. Incorrect Property Identification:

The CAO announced the wrong property address both in the written public notice on the app used for official announcements and again verbally during the first auction.

4. Inconsistent Bidding Increments:

During the first auction, the CAO changed the minimum bid increase amount midway through the bidding process without prior notice.

5. Failure to Properly Announce the Third Auction:

The third auction was not announced on the app used for public notifications, and it



began before the posted start time of 10:00 a.m.

6. New Rule Introduced Mid-Auction:

At the third auction, the CAO suddenly introduced a new rule requiring anyone bidding on behalf of another person to declare it before bidding. This rule had not been previously communicated.

7. Conflict of Interest - Council Member Participation:

A sitting council member was permitted to bid on and ultimately win the property for himself. This same councilor held the keys to the house, creating a clear conflict of interest.

- Prior to the auction, all blinds and windows of the property were closed, preventing potential bidders from viewing the interior.
- After the council member won the bid, he opened the windows and blinds immediately, suggesting he had privileged access and inside knowledge of the property's condition.

8. Dismissal of Concerns:

When I raised my concerns about these irregularities, I was told that if I wished to pursue the matter further, I would need to take it to the **Supreme Court**.

I believe the way this sale was conducted undermines public confidence in the fairness and transparency of local government processes. I respectfully request that your office review this matter to determine whether the Village of Clinton acted appropriately and in accordance with provincial and municipal standards.

Thank you for your time and attention to this complaint. I would appreciate confirmation of receipt and any information on the next steps in the review process.

Background:

With the upcoming approval of the OCP and Zoning Bylaw, Administration has identified the need to consider some new bylaws and amendments to existing bylaws. These are as a result of either the public feedback received by the village, or new additions to the Zoning Bylaw that need to be expanded upon. The following changes are recommended:

New Bylaws

Parking Reserve Bylaw – To establish a reserve fund in which fees payments in lieu of parking spaces can be held, as a requirement of the Community Charter

Payments in Lieu of Parking Bylaw – To set the terms and limits on how many spaces by which a property owner can reduce their obligations under the zoning bylaw, and how much must be paid to the Village in response.

Delegation Bylaw – To permit staff to authorize technical Development Variance Permits that rely on professional submissions such as Wildfire Hazard, Steep Slope, and Streamside DVPs.

Amendments to Existing Bylaws

Fees and charges – To update fees to amend OCP and Zoning bylaw. OCP amendments to be more prohibitive, rezoning to commercial to be less prohibitive

Animal Control – To set limits on livestock, and expand the small-scale agriculture permitted in residential zones **Bylaw Notice Enforcement** – To expand enforceability of the new zoning bylaw.

Some of these bylaws will be presented at the December 10th meeting, but others may be brought forward in January as time permits.

<u>Meetings Attended</u> Thrid pre budget meeting 1st draft all departments did their SWAT analysis on their departments. At present there seems to be an overall increase of 9.7% with the municipal portions looking at an increase of 8.67%. as BC assessment isn't out until end of December it's difficult to predict, also the provisional budget will be presented at the end of December. Some of the drivers in taxation is that the technology is becoming outdated and inefficient, there is an increase in public expectations with limited revenue opportunities.

They are looking at a service area review as there is lots of new construction as well as new owners with different viewpoints and needs.

Solid waste management is going through a service review. Looking for an increase in public education as well as public events. Mattress recycling has been free for homeowners and a fee for commercial drop-offs. The board moved for a fee of \$20.00 for homeowners and \$35.00 for commercial drop-offs. As the only recycling facility is in Hope and the costs for transportation is ever increasing and with the province unwilling to add this to their recycling program with upfront fee (as in the tires) the board felt the need to move away from free drop-offs.

TNRD hospital board: presentation from the Kamloops cancer centre supportive care society. Non-profit society since 2021, their mandate is to reduce the burden on the health care system by providing patients with supportive cancer care needs. They are opening an office in Kamloops square in January of 2026 as a resource for patients and caregivers.

Presentation by Interior Health. There are 4 pilot programs in delivering virtual care for ER services. (clearwater and Lillooet in our service area) There will be a nurse on site but rural emergency health will be virtual.



Council Report

Emergency services: there was a great deal of discussion around Fire underwriters insurance for Fire trucks and equipment. It is an American company that dictates when perfectly good trucks need to be replaced and the replacement timeframe is ever widening. Some areas are refitting their old trucks and renting them out to BC wildfire. BC assessment is doing a review of all pipelines and how they are taxed. This does not affect Clinton currently but reduces the taxation for many other areas. The thought is that the rail lines will go under a similar review for a tax reduction, thereby increasing the taxation burden on homeowners.
